

## Summary/Objective

Reporting to the Chief Technology Officer (CTO), this position is a key strategic position within the organization that is responsible for architecting and designing complex regional and campus network infrastructures. This role works closely with the CTO to identify professional services engagement opportunities within the LEARN community. The ideal candidate will possess the ability to work positively with a wide range of individuals. This individual will require minimum supervision and will have strong organizational and analytical skills with the ability to understand and break down complex technology concepts and communicate it to nontechnical stakeholders.

The individual will work in a small team environment but will have significant interaction with network and service providers and members ranging from K-20, higher education, system networks, other regional and national networks, content providers, and application providers.

**Position Location:** This position requires the candidate to operate from a home office in a virtual office environment. Dallas/Fort Worth Metroplex preferred, Texas residence required.

Travel Requirements: Occasional travel to LEARN member locations throughout the state of Texas.

### Functions and Areas of Responsibility

### **Professional Services Engagements**

- Leads the assessment of prospect or member technical requirements and creates proposals outlining network architecture design solutions. Works with CTO to identify engagement scope for professional services to implement design.
- Leads and oversees multiple initiatives and prospect/member engagements to ensure that scopes, budgets, revenue targets and project deadlines are planned and met.
- Collaborate with CTO & Network Services Director in developing new managed services engagements resulting from professional service implementations.
- Collaborates with other leaders to prioritize projects, develop, and implement plans, and manage resources and priorities for the organization.
- · Identify key requirements needed from cross-functional teams and external vendors.
- Work with the Leadership Team to identify risks and opportunities across multiple professional services engagements.
- Responsible for presenting network design proposals to members including formal presentations to large audiences.
- Serve as technical Subject Matter Expert and advocate for LEARN professional services at outreach events such as board meetings, technical workshops, and other community events.

### **Network Architecture Design**

- In partnership with key stakeholders, develops enterprise network architecture design principles, standards, and multi-year refresh plans and budgetary requirements for Campus Wide Area, Border, Core, Edge, Data Center, and Wireless networks.
- Research current and emerging network infrastructure technologies.

- Provide engineering and support services as needed for LEARN regional state-wide network operation.
  This includes serving as a technical lead for projects associated with optical and packet network technologies.
- Serve as second-tier support for network operations and participate in on-call rotation as needed.
- Provide coaching and mentorship to members of the engineering team and Interns.
- Interact and collaborate with vendors and contractors for product/platform evaluation, technical implementation and planning, and procuring network products and services.
- Develop, implement, and maintain standard operational procedures and established standards.

- Bachelor's Degree with minimum of ten years of experience working directly with complex network environments.
- · Current network certification from Arista, Cisco, Juniper, or Nokia.
- Proven experience with advanced service provider and WAN router configurations utilizing logical systems, BGP in a multi-homed environment, IPv4, IPv6, ISIS, OSPF, MPLS, LACP, LDP, L2 and L3 VPN, VPLS, EVPN, QoS, 802.1q, 802.1p and IP Multicasting technologies.
- A working knowledge of networking protocols, with a thorough understanding of TCP/IP, IPv4/v6 address management, and DNS.
- Proven experience with network management and monitoring systems and diagnostic tools commonly used within the service provider networks.
- Proven working experience with Next-Generation Firewalls, Intrusion Prevention Systems (IPS) and Intrusion Detection Systems (IDS).
- Knowledge of fiber optic technologies and Layer 1 protocols & technologies.
- Must be able to conform to shifting priorities, demands and timelines through analytical, organizational, and problem-solving capabilities.
- Experience at working both independently and in a team-oriented, collaborative environment is essential. This role will work closely with other, non-technical departments.
- Experience managing multiple complex projects, with proven ability to execute projects on time and on budget.
- Excellent written and verbal communication skills; experience presenting and communicating to executives.
- Must be able to lead and motivate project teams and meet specified deadlines.
- Exceptional leadership, time management, facilitation, and organizational skills.
- Proficiency in MS Office applications.
